

GIS / Mapping Technician.

The position will be responsible for data entry, quality control, and some interface modifications as they relate to water and waste assets. The GIS / Mapping Technician will perform all functions related to data acquisition and mapping, not limited to those identified in duties and responsibilities.

Responsibilities:

- Integrates data from multiple sources into utility mapping system using GIS software.
- Assist in maintaining an organized database of record drawings, plats, easements, and utility infrastructure.
- Maintains current drawings and databases of utility infrastructure.
- Gathers, organizes, interprets, and verifies data 3rd party sources.
- Collects field data using GPS equipment to acquire topographic, cadastral, and physical feature data.
- Prepares exhibits and customized maps for records, reports, and meetings.
- Compiles and organizes geographic information in the form of satellite images, geographical surveys, and aerial photographs.
- Ensures maps are annotated and compiled with the correct information, maintaining data integrity and accuracy.
- Delivers training and technical support to end-users.
- Assist in maintaining the GIS database and troubleshooting data issues.
- Coordinates with various internal and external departments such as field operations, IT, and city planning to ensure acquisition and dissemination of accurate information and data.
- Not a work from home position. Requires on-sight presence.

- Equivalent to four year college degree in GIS, Geography, Surveying, Engineering Technology, Computer Science, or related field.
